Terms & Conditions – A Summary

These Terms & Conditions (“Terms”) govern access to and use of:

- **Intuitships-UMMS** (web-based application)
- **Intuit U** (Android and iOS mobile applications)

Collectively referred to as the “**Service.**”

The Service is an **enterprise maritime ERP and asset management system** developed by **Vollzo Consulting, LLC** (“Vollzo,” “we,” “us”) for **Union Marine Management Services (UMMS), Singapore** (“Client”).

By accessing or using the Service, you agree to be bound by these Terms.

1. Eligibility & Authorized Use

- The Service is intended **solely for authorized employees, contractors, or representatives** of UMMS or its affiliated entities.
- Access is granted **only through employer-approved credentials**.
- There is **no public registration or consumer use** of the Service.

If you are not an authorized user, you must not access or use the Service.

2. Account Management

- User accounts are created, managed, and removed **exclusively by UMMS administrators**.
- Users are not allowed to create, transfer, share, or sublicense accounts.
- You are responsible for maintaining the confidentiality of your login credentials.

UMMS reserves the right to suspend or terminate access at any time, in accordance with its internal policies.

3. Acceptable Use

You agree to use the Service only:

- For legitimate business purposes
- In compliance with applicable laws, maritime regulations, and company policies

You must **not**:

- Attempt unauthorized access or security circumvention
- Interfere with system performance or integrity
- Upload malicious code or misuse system data
- Use the Service for unlawful, deceptive, or harmful activities

4. Data Privacy

- Use of the Service is subject to the **Privacy Policy**, which forms an integral part of these Terms.

- Personal and operational data is processed **solely for enterprise, regulatory, and security purposes**.
- The Service does **not** support advertising, marketing, or data monetization.

5. Intellectual Property

- The Service, including software, source code, interfaces, trademarks, and documentation, is the **intellectual property of Vollzo Consulting, LLC**, unless otherwise agreed in writing.
- UMMS and its users receive a **limited, non-exclusive, non-transferable license** to use the Service for internal business operations only.

No rights are granted beyond those expressly stated.

6. Availability & Maintenance

- The Service is provided on an “**as-is**” and “**as-available**” basis.
- Scheduled maintenance, updates, or emergency downtime may occur.
- Vollzo does not guarantee uninterrupted or error-free operation.

7. Mobile App Terms

- Maritime IMO cybersecurity guidelines
- Mobile app availability is subject to **Google Play Store** and **Apple App Store** platform requirements.
- Vollzo is not responsible for device compatibility, OS limitations, or third-party platform outages.
- App updates may be required to continue use.

8. Termination of Access

Access to the Service will end when:

- Employment or contractual relationship with UMMS ends
- Access is revoked by UMMS
- These Terms are violated

Upon termination, user access is disabled, and data is handled per the Privacy Policy.

9. Disclaimers

- The Service is a **business support system**, not a substitute for professional judgment.
- Vollzo does not guarantee regulatory outcomes, operational decisions, or business results based on Service use.
- Users are responsible for verifying outputs before operational or regulatory submission.

10. Limitation of Liability

To the maximum extent permitted by law:

- Vollzo shall not be liable for indirect, incidental, or consequential damages
- Liability is limited to damages arising from willful misconduct or gross negligence only

Some jurisdictions do not allow certain limitations; applicable law will govern.

11. Indemnification

You agree to indemnify and hold harmless Vollzo from claims arising out of:

- Unauthorized use of the Service
- Violation of these Terms
- Breach of applicable laws or company policies

12. Governing Law & Jurisdiction

- These Terms are governed by the laws applicable under the commercial agreement between Vollzo and UMMS.
- Any disputes shall be resolved in accordance with that agreement.

Vollzo may update these Terms from time to time.

Material changes will be communicated through the Service or via UMMS.

Continued use of the Service constitutes acceptance of updated Terms.
